Summary:

The MBU grounds department would like to hire student grounds care workers to help maintain the campus during the snow season.

Essential Duties and Responsibilities:

- Clearing designated areas of snow, including parking areas, sidewalks, and driveways during the winter season.
- Perform snow and ice control and removal procedures including sanding, spreading deicing chemicals, loading trucks, hauling snow, or assisting other mechanics in the maintenance of snow removal.
- Hours vary according to weather conditions, but position often requires early morning work hours.

Other Duties & Responsibilities:

Other duties may be assigned.

Supervisory Responsibilities:

This position does not have supervisory responsibilities.

Qualification Requirements:

Individual drivers must be at least 18 years old. If the individual has a valid driver's license, he or she must have an acceptable driving record. The individual must also demonstrate the mature handling of equipment.

- Education:
 - High School graduate
- Language Skills:
 - Ability to read and comprehend simple instructions.
 - Ability to write simple correspondence. Ability to effectively present information in a one-on-one and small group situation to supervisor or other employee.
- Mathematical Skills:
 - Ability to add and subtract two digit numbers and to multiply and divide with 10's and 100's.

- Ability to perform these operations using units of American weight measurement, volume and distance.
- Reasoning Ability:
 - Ability to apply common sense understanding to carry out simple one or two-step instructions.
 - Ability to deal with standardized situations with only occasional or no variables.

Physical Demands:

The physical demands described here are representative of those that must be met by an employee to successfully perform the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

While performing the duties of this job:

- The employee is regularly required to stand; use hands or fingers, handle or feel objects, tools, or controls; and reach with hands and arms.
- The employee frequently is required to walk and stoop, kneel, crouch, crawl, or climb ladders.
- The employee is occasionally required to climb or balance and talk or hear.
- The employee must frequently lift and/or move up to 50 pounds and occasionally move more than 50 pounds.
- The employee is required to see clearly, both near and far.
- The employee is required to endure substantial physical activity.

Work Environment:

The work environment characteristics described here are representative of those an employee encounters while performing the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

While performing the duties of this job:

- The employee is regularly exposed to changing climate conditions.
- The employee is frequently exposed to fumes or airborne particles and toxic or caustic chemicals.
- The employee frequently works near moving mechanical parts.
- The noise level in the work environment is usually moderate and hearing protection devices are available.
- This position will occasionally require 2nd shift or weekend hours.
 - Hours may vary due to snowfall, daylight, adverse weather conditions, etc.
